Report.

HE following is the Report by the Committee for the Session 1890-91.

There were 114 Members enrolled of whom

There were 114 Members enrolled, of whom 8 were Overseers, 65 Journeymen, and 41 Apprentices. Of these, 49 entered for Practical Instruction. There are now 20 Honorary Members on the Roll, and the Committee take this opportunity of thanking them for their kindly interest and liberal support.

During the Session there were five Lectures delivered under the auspices of the Association, open to all connected with the Printing Trade. The Opening Lecture was given by Professor Baldwin Brown on "The Book before Printing"; followed by Mr. T. A. Croal, F.S.A. Scot., on "Books, Newspapers, and Publishers in the Dear Days"; Mr. G. D. Bishop on "James Smith, Printer and Poet"; Mr. R. W. Henderson on "The Art of Typefounding"; while the series was concluded by Mr. Robert Irvine, F.C.S., on "The Chemistry of Colour Printing." To these gentlemen the thanks of the Association are due for their able and most interesting Lectures; and also to Mr. D. J. Vallance, who for the second year in succession conducted a large party of the Members through the Museum of Science and Art in one of his very instructive Museum Walks.

Besides the Lectures, eight papers were contributed by Members, for whose kindness in acceding to their request, the thanks of the Committee are recorded. At the conclusion of each paper a short discussion ensued.

The teaching at the Classes throughout the past Session has been almost wholly practical, and under the charge of Messrs. Porteous, Grut, Weir, and Short. The Association is under a deep obligation to these gentlemen for their labour of love. Mr. Porteous, who has taken such a great interest in the Classes, was compelled through illness to resign his position, and the major portion of the work fell upon Mr. Grut, whose energy and enthusiasm, not only in connection with the Classes but with the entire work of the Association, are deserving of the highest praise. The following is Mr. Grut's Report:—

"The duration of the Classes extended over four and a half months. The number of students who entered was 40: and the average attendance for the six weeks before the New Year holidays was 21; for January and February, 18; and for March, 13. Eight candidates came forward for the Examination held on 1st April—five passing and receiving certificates, the first three also being awarded prizes. The disparity between those enrolled and those in attendance may be explained by many preferring only those subjects on which they desired information or instruction. The interest shown by those who did attend was very encouraging. The aim kept in view was not so much to coach the students to pass an examination, as to show them the 'why and the wherefore' of the work undertaken. But it is evident that if we are to go in for examination by the Local Authority, or the City and Guilds Institute of London, it will be necessary not only to instruct in technical subjects but also to see that the students can work out quickly sums in arithmetic. There is one fact brought out forcibly in the teaching of the Classes, that so far as compositors are concerned they ought always to be keeping up their school education. There are situations in the trade where the deficiency of education makes little difference, but for the great majority of compositors education is indispensable if their earnings are to be worth the time given to their occupation."

Mr. Finlayson took charge of the class for music-setting. As this can only be taught by actual work at the case, only two could be taken in hand at one time. Eight students availed themselves of Mr. Finlayson's teaching.

The Committee have received and acknowledged, on behalf of the Association, donations of the following books: 20 vols. Encyclopædia Britannica, 5th edition, and 47 vols. Annual Register (1759-1794), from the Printers' Library; a copy of Printers and Printing in Glasgow from 1830 to 1890, from the author, Mr. Aird, of the Glasgow Branch of the Typographia. They have also much pleasure in expressing their indebtedness to Messrs. Furnival & Co. for their handsome gift of thirteen framed photographs of machinery.

There have been two Social Gatherings of the members under the auspices of the Association. The following is Mr. Grut's Report:—

"The duration of the Classes extended over four and a half months. The number of students who entered was 49; and the average attendance for the six weeks before the New Year holidays was 21; for January and February, 18; and for March, 13. Eight candidates came forward for the Examination held on 1st April—five passing and receiving certificates, the first three also being awarded prizes. The disparity between those enrolled and those in attendance may be explained by many preferring only those subjects on which they desired information or instruction. The interest shown by those who did attend was very encouraging. As regards the so-called parent Association—the British Typographia—the Committee have nothing further to report. Its existence or non-existence is still a matter of doubt.

As will be seen from the Treasurer's Statement, there is a good balance in hand with which to commence work next session.

In conclusion, the Committee would respectfully urge upon the attention of the members the necessity for an increased membership. If for no other reason than that of providing opportunities for intercourse between those engaged in the trade, and encouraging the discussion of matters intimately connected with their business, the Association ought to be very much better supported than it is. Complaints are heard of, among other things, the want of proper accommodation for the Reading Room; but only let the Trade provide the members, the Association will do the rest. The Committee therefore trust that the members will see it to be their duty to make known the claims of the Typographia, and help to make it worthier of the principal trade of the city.
